Typical values for the coefficient of retroreflection (R´) for ORALITE® 5230M Prismatic Economy Grade are shown in Table 1 when illuminated with CIE standard illuminant A and measured with the provisions of CIE no. 54. The values are an average of rotation angles 0° and 90°.

Colour

ORALITE® 5230M Prismatic Economy Grade is available in white (010) and yellow (020). The colour shall be within the area defined by the chromaticity coordinates and luminance factor provided in Table 2, when measured in accordance with the provisions of CIE No. 15.2 (illuminant D₆₅).
